Stopped The device is unavailable but remains known by its device driver.

Only one of these devices can be configured at a time. When the tty connector is configured, the printer specific setup information is retained until it is configured again. The device is not removed; it is in the defined state. Maintaining a device in defined state retains customized information for a device that is not currently in use, either before it is first made available or while it is temporarily removed from the system.

If a device driver exists for a device, the device can be made available through the device driver.


